## **COUNCIL ELECTIONS 2025**

**From FDI Constitution:** No person shall serve as a Councillor for more than six years or in any capacity on Council for more than 13 years in total.

## There are three vacancies: one vacancy for the President-elect and two vacancies for the Council.

One vacancy for the Council is open for nominations from North America only. The vacancy for President-elect and the second vacancy for Council are open to nominations from all Geographic Areas. All members are to be elected by the General Assembly.
